Textual Information(1)	Company has issued 58,37,143 Fully Convertible Warrants each convertible into or exchangeable for 1(One) fully paid-up equity shares of the Company having face value of Rs. 10/- each at a Price (including the warrant subscription price and the warrant exercise price) of Rs. 70/- (Rupees Seventy Only) each payable in cash (Warrants issue Price) on preferential basis to the identified Non- promoters, Public Category upon receipt of 25% of issue price from the allottees (warrant holders), in accordance with the provisions of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 and warrants holders requires to pay 75% of the issue price of warrants was to be paid at the time of exercise of option to apply for fully paid up Equity shares of Rs. 10/- each of the Company, against each such warrants held by the warrant holder within a period of 18 months from the date of allotment.
